

- parents and carers must ensure they notify us of any changes to the information given on the form
- parents and carers must make arrangements for the child/young person to be brought to and from the activity safely and on time. If a parent or carer is not able to collect their child/young person, they need to let us know in advance who will be doing so
- we cannot take responsibility for any damaged clothing and/or personal items during the activity
- parents and carers should ensure their child/young person has sufficient water, food, clothing, sun location and medication (where appropriate) for the duration of the activity

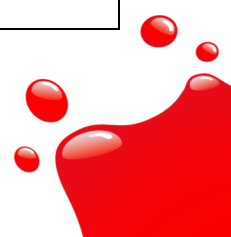
- my child/young person taking part in the stated activity

Release, Indemnity and Waiver

Risk Warning:



This consent/waiver is given in respect of each of the activities indicated/ticked on the reverse of this form.

I understand that some TAG activities can be very dangerous and have a potential for serious injury or even death. I understand that it is necessary for my child to follow and comply with the directions and instructions from staff including internal and external coaches and instructors at all times.

My child is voluntarily participating in the activity at their own risk for the purpose of recreation, enjoyment and leisure with the knowledge of the dangers involved, and I agree to accept any and all risks of loss, injury or death.

I understand suitable footwear and clothing must be worn to participate and if staff, coaches or instructors feel your child is a risk to themselves or others in the session they will be asked to sit out for a period of time.

Release, Indemnity and Waiver:

By participating in activities, I agree:

- a. to release and hold harmless TAG Youth Club and its staff and members from all liability and claims that I may have or may have had but for this release arising from my child's participation in the activities;
- b. to indemnify and hold harmless TAG Youth Club, its staff or members to the extent permitted by law in respect of any claims brought by any other person (including but not only limited to any other participant), arising as a result of or in connection with my child's participation in the activities; and
- c. that if my child suffers harm doing any of the activities, I will not hold TAG Youth Club, its staff or members legally responsible for any injuries my child suffers and I will not sue TAG Youth Club, its staff or members for any claims, costs, medical expenses, damages or liabilities my child may have incurred as a result of such participation.
